We at SACHETAN firmly believe that creative engagement with children and youth is a key to building a society with quality human capital. As an organization we have chosen to assume the responsibility of facilitating this engagement, by nurturing and empowering them to become responsible citizens.

In the first year of learning we have begun working with children and students as a group to provide them with creative and innovative ways of learning and enabling for better future. We focused on adolescent girls and their issues related to education, health and life skills. To some extent, we have been able to understand what and how is needed to be delivered; and are in the process of expanding the involvement and to shape the learning into project form to work on with more consistency.

This is very inspiring moment for Team SACHETAN to present its first annual report which reflects our learning and journey of voluntary efforts. Happy Reading!

Vision

Our dream is to have an equal and socially conscious society, composed of educated and capable individuals with healthy mind, body and soul.

Mission

To promote efforts to impact different strata and segments of society through integrated approaches to create progressive change in society. We emphasises the importance of stimulating young minds, which helps to empower individuals to make conscious choices that impact their own lives.

Glimpses of Activities

Our core programmatic areas are education, health, gender and life skills issues. We apply several methodologies to work with children and adolescent girls. Some of our programme activities include:

Story Workshops for Enhancement of Educational Competencies

Considering reading, listening and drawing skills as important tool of enhancing the skill of imagination, concentration, articulation power of children, we focused on 'story'. Story as methodology is used in various ways whether it is story telling mode or building/creating the stories by children themselves. Both give space to



imagination as well as creative struggle with language, vocabulary and logical placing of events. We conducted story workshops for the students to develop and enhancing the basic educational competencies like reading and writing by promoting creative thinking and writing, vocabulary building and presentation skills. We engaged with 142 school going children through these workshops at various locations in which they attempted to think of a story, write a story and then present the story.

ArtLabs for Creative Engagement



We believe in social function of art that it has immense possibilities to lead social, cultural and environmental change. Our ArtLabs are medium to inspire learning and spread social messages with creativity. ArtLabs are for seeding the thought of '*do it yourself*' among children. We conducted ArtLabs with school and non-school going children both at various locations. These ArtLabs encourage children to explore their creative talent and to engage in creative assignments. The ArtLabs are theme based like; save environment through creative alteration of plastic bottles; paper craft-flowers and other objects through waste magazines and newspapers ; colouring of earthen lamps etc. The basic idea of ArtLabs is to promote '*do-it-yourself*' behaviour among children for creative utilization of available resources and come out with new ideas of their own.

Body Movement Workshop

Seven days body movement workshop was organized for the girls of observation home (Nari Niketan).



The workshop used the folk dance forms like Garba-Dandiya and Ghoomer as a strategy to work on values like collective strength, synchronization, system and functionality, boundaries and space etc. The workshop provided the girls an opportunity to have a break from routine and monotonous life of observation home. The girls were also taught to prepare

dandia-sticks. The girls who could not participated in the dances, took lead in dandia sticks preparations. This seven days workshop established a rapport between us and the girls of the home which has motivated us to plan a long term intervention for them.

SELF Programme : Working with Adolescent Girls

SELF stands for **Self- Exploring, Self-Leading and Self-Fostering**. This SELF training program is designed for the adolescent girls who are, due to adverse circumstances in life, got to live in Balika Grah: Observation home run by Department of Social Justice and Empowerment, Kota. Through SELF program SACHETAN wishes to empower the girls with such skills so that they could be able to explore themselves, have their own decisions to make informed choices and take care of themselves to live with dignity after release from Balika Grah. We started a pilot project for four months (December 2013 – March 2014 and three days in a week) for girls of Balika Grah, which was focused on improvement/refresh of basic literacy skills and enhanced understanding on various issues of health, livelihood, legal rights, etc through various thematic workshops. 21 girls (whosoever was admitted there) participated in SELF program. We worked with the girls who were in the age group of 12- 18 years and maximum could not be linked with the formal schooling system. As a result of this pilot project the girls could able to retrieve their literacy skills and gradually gained interest in the studies. They showed their interest in continue their education through Open School or other distance education. The girls who were below 14, have been recommended to be linked with local school in the coming session.

Activities under 'SELF': Besides literacy classes following activities/ sessions were also offered -

- **Akhbaar** (Newsletter writing)
- **Menstrual Health Management (Phase 1):** Listing of practices
- **Menstrual Health Management (Phase 2):** Training on home-made cloth sanitary napkins
- **Interactive Session with Some Women Established in their Fields** (Scientist, Theatre, Human Rights, Social work, Education)
- **Origami Workshop** facilitated by student volunteers
- **Personal Care through Natural Methods**

Safe City for Women and Girls

Poster Exhibition: Working to create safer city for women and girls is a part of broader concern to end violence against women and girls. In support of the idea we invited everybody...from students to senior citizens of the city to express their feelings on the issue through Art by making posters. We received an overwhelming response from students, housewives, teachers, senior citizens and freelance artists for the purpose. The posters received were showcased through an exhibition organised at Art Gallery, Kota. Prof SC Rajora, Dean and Head of Department of Social Sciences, University of Kota graced the occasion as Chief Guest.

Students' Voices: Rapid Assessment: In the continuation of the concern creating safer city for women and girls, we conducted an Interaction with students of 10th standard of Central Academy School. The objective of the Interaction was 'Identification of risky/unsafe/uncomfortable areas in the city to move around for women and girls' and 'understanding the factors what makes the public spaces uncomfortable to women and girls' and finally the innovative suggestions/ measures to makes such zones safe for them. The students earmarked the locations unsafe for girls from their perspective. This was the first interaction to understand the students 'voices on the issue. A series of discussion on the same is planned for others schools too so that gradually, a safe city plan could be shared with the local police department of the city.

Celebrations, Conferences and other Events

- **National Sports Day** was celebrated with the girls of observation home and also with the primary students of Harijan Basti Ganeshpura School. A one day workshop was organized in which they recalled the 'games we played in childhood'. Creative exercise and games were also played by the girls in the workshop.
- Facilitated discussions among children on **child rights issues to be reviewed and incorporated in the election manifestos of political parties** respectively at Pragati International School, Ujjwal Vihar and Mary Children School, Sunder Nagar where total 65 students from class 9th to 12th participated in the event.
- On behalf of the organization Dr. Bharti Gaur participated and got felicitated in the **national conference (4-5 October 2013) on 'Female Feticide- Socio-legal issues and challenges'** organized by women cell of University of Kota and National Commission for Women, Delhi.
- Celebrated **International Women's day** with residents of Nari Niketan. The event was chaired by Rashmi Sharma, District Education Officer (Elementary). Several leading women from different fields like science, theatre, human rights, social work and education were called in the

event and an interaction session with the girls was arranged to motivate the girls for their better future. A poster exhibition was also organised on the occasion.

- Lecture on SMART goals was delivered to the volunteers of National Service Scheme (NSS) of Mahatma Gandhi Senior Secondary School, Rampura.
- The responsibility of celebration of *Bal Diwas* under the celebration of '*Samaj Kalyan Saptah*' was given to us by the district administration and officials of Social Justice and Empowerment Department, Kota. The resident girls of the observation home gave performances on Ghoomer and Garba dance forms which they learned in Body Movement workshop organised by us.
- Initiated a support centre named Sanjhi, for girls of observation homes to provide them post-release support through counselling, education and skill training etc. So far two girls have been supported through linking them tailoring course at their native places.

Documentation

These are some of our activity reports with detailed process and achievements. All these reports are available on the website also.

Understanding Aspirations report is the documentation of one day event experience with the resident girls of Balika Grah to commemorate National Sports Day. It also provides us the glimpses of dreams and aspirations of the girls at Balika Grah.

Daayre: Seemittatayen aur Vistaar (Hindi) is based on seven days workshop on body movement and folk dances and submitted to Department of Social Justice and Empowerment, Kota. It shares the experiences of girls over the workshop in detail.

Kahen kahani Rachen Khanai (Hindi) is the documentation of experiences of story workshops at various locations. It presents the happenings of each story workshop in detail.

ArtLab at Saharia Basti report captures the one day event process of make-over of earthen deepaks by drop out children of Saharia Basti.

Bal Diwas Utsav is a photo documentation of the children's day celebration and performances of resident girls of observation home on the occasion of social welfare week.

SELF (Hindi) is a report of pilot project on educational intervention for girls of observation home. It gives account of methodology of literacy sessions and workshop on menstrual health management and personal care. The report has been submitted to the Department of Social Justice and Empowerment, Kota.
